In our area, we currently have Best Buy, CVS, Fed Ex, Dicks, Amazon and now Meble. These Distribution Centers may attract other warehouse/distribution centers to the area. Jobs range from entry level to more advanced positions.

Tioga Career Center is working with Meble Furniture to access other services including Department of Labor Business Services and assisting in job posting, On the Job Training (OJT) opportunities and hiring.

WHEREAS: All adults, youth and children should be aware of and be able to recognize the signs of commercial sexual exploitation of children, the risk it poses to our youth and the importance of children having a safe, risk-free community within which to live; therefore
