# Tioga County Industrial Development Agency Board of Directors Minutes August 6, 2014

1. Call to Order and Introductions – the meeting was called to order by the Chair, R. Kelsey at 5:30 p.m.

- **3. Privilege of the Floor** Chair Kelsey noted that Mr. Daniels has submitted his resignation because he is relocating for his job. Chair Kelsey thanked Mr. Daniels for serving on the board and the entire board wishes him well on his new venture. Mr. Daniels thanked the board for being selected to serve on the board and appreciated the opportunity to participate on a board that truly makes a difference.
- 4. Update - Richard D'Attilio – Mr. D'Attilio gave an update of his most recent interaction with the parties involved in the E-Site Development Project. He is most active with Home Leasing and Edgemere. Edgemere is in the process of applying through CDBG DR funding as well as a federal source of tax exempt bonds. He most recently had conversation with Stephanie Benson and John Oster from Edgemere. Ms. Benson was under the impression that the implementation of the infrastructure was much further along than it is. Ms. Benson and Mr. D'Attilio talked about a PILOT and the need for the PILOT to coincide with their tax exempt bonds. He noted that Delta really needs to move along to get infrastructure cost established and is hoping that the board will approve Delta's Concept Design Proposal to prepare a budgetary construction cost estimate for this project. Edgemere is looking to start construction in April 2015, so time is of the essence. Mr. D'Attilio had conversation with Nelson Leenhouts at Home Leasing to inquiry about whether or not Home Leasing would help develop the road. Mr. Leenhouts stated that there may be a way they could assist with building the road but it would depend on his funding sources. The proposed Home Leasing project is a real opportunity, and Mr. Leenhouts has accelerated his plan and wants to build 15 single family homes on the site as well. Mr. Leenhouts will be sending out request for qualifications to local engineering firms. Mr. D'Attilio referred Mr. Leenhouts to Delta Engineers since the IDA is currently working with them. Delta Engineers is in the process of developing a proposal for their consideration. Home Leasing and Edgemere are very enthusiastic about this project; reenforcing of the IDA's commitment needs to be done by action and keeping the development of the site moving. Mr. D'Attilio met with David Chase to discuss the concept design proposal that

has been submitted for your review and approval at this meeting. The sooner we know what the costs are going to be, the better we can determine the funding sources. Mr. D'Attilio suggested that it would be helpful if the IDA didn't have to use the land proceeds to payback STREDC but instead use them to help with the infrastructure cost. Mr. D'Attilio had a teleconference with David Chase, Ruth Fiato and Paula McEvoy to discuss the opportunity to individually meter the water lines to capture the rebate per meter. The rebate with help pay for the installation of the water line. Mr. D'Attilio also asked United Water about assisting in the cost of the water tank; Ms. McEvoy said she would approach corporate about this matter. Mr. D'Attilio sent an email to SDP to find out if they are still interested in pursuing a greenhouse project in Owego; Mr. Roy Alston from SDP responded to the email and stated that SDP is still comfortable with exploring the development of a greenhouse project in Owego. Continued dialog with all parties will take place to move the project forward.
