- A proposal for cleaning the entire Waverly Village Hall building was presented to the committee. This could help offset the cost of rent.
 A few concerns need to be researched. Public Works will report back on these concerns in February.
- Work is continuing in the basement of the Clerk's office for ILS.
- The 2nd floor offices were moved back at 56 Main Street.
- The 1st floor offices were moved into the basement at 56 Main Street.
- The large wooden doors to the court room at the court house were repaired.
- A large amount of work orders at the PSB Building were completed.
- A large amount of work orders at the HHS Building were completed.
- We've received a proposal from LCP Group, Inc. for the demolition of the red barn on the Delphine Street property. A resolution to award this proposal will be brought to our February meeting.
- The Walgreens building in Owego is for sale. The county has space needs. After some discussion the committee agreed that this is worth exploring further.

 - Buildings and Grounds
 - Court Annex/Clerks roof stamped drawings have been received and are being reviewed.
 - Court Annex HVAC Project Carrier unit is in storage at P&J's facility.

WHEREAS: Two boilers at the Public Safety Building are obsolete and failing; and
