## HIGHWAY

- 1. Mr. Hammond stated that the skidsteer with the milling head was used on cross pipes at Pennsylvania Avenue and box culvert. Everything has been paved.
- 2. Ditching operations and shoulder work was done on Day Hollow Road.
- 3. Ditch and pipe cleaning operations were done on Sulphur Springs, Wilson Creek and West Creek Roads as a result of the flash flooding event on October 31<sup>st</sup>.
- 4. Cold patching was done on various roads.
- 5. Stream cleaning was done on West Creek Road and Pennsylvania Avenue.
- 6. Equipment was readied for snow removal.
- 7. Snow removal and sanding operations have begun for the season.

## CAPITAL PROJECTS

- 1. Mr. Perkins stated West River Drive at Mount Pleasant Road culvert is done and has been reopened.
- 2. West River Drive over Parks Creek will go out to bid in early spring.
- 3. West Creek Road over Owego Creek is expected to be done next year.
- 4. Oak Hill Road Bridge is expected to be finished within 2 weeks.
- 5. Bridge Preventive Maintenance Phase IV is complete.
- 6. Bridge Preventive Maintenance Phase V will start in early spring.
- 7. Bridge Preventive Maintenance Phase VI will go out to bid next summer.
