### **MINUTES APPROVAL**

The minutes for the January 7, 2021 meeting were reviewed by the committee. Mr. Weston made a motion to approve the minutes as written and Mr. Standinger seconded the motion; the minutes were approved as written.

### SOLID WASTE

1. Ms. Pratt reported that the recycling transition appears to be going smoothly. She will continue to monitor the recycling being collected through the various private companies.

### **BUILDINGS & GROUNDS**

- Mr. Hammond stated our natural gas supply contract through MEGA with Direct Energy will be expiring. A cost comparison was generated for the actual natural gas supply costs for the last three years under Direct Energy's fixed rate contract versus what the monthly cost of natural gas supply would have been for NYSEG's variable rate. It was shown with a three year cost analysis that considerable savings could be recognized by switching to NYSEG's variable rate pricing. After some discussion, it was decided that we should switch to NYSEG for our natural gas supply. Public Works administration will continue to monitor this.
- 2. Snow removal operations are ongoing.
- 3. A bookcase was built for the investigators at the Public Safety Building.
- 4. Painting on the 1<sup>st</sup> floor at the HHS Building has been started.
- 5. An office was moved for Probation.
- 6. A storage room was created for the District Attorney.
