NOTICE OF PUBLIC HEARING Due to the Novel Coronavirus (COVID-19) Emergency and State and Federal bans on large meetings or gatherings and pursuant to Governor Cuomo's Executive Order 202.1 issued on March 12, 2020 suspending the Open Meetings Law, and extended through June 24, 2021 by Executive Order 202.109, a public hearing scheduled for June 23, 2021 at 5:00 p.m., local time, is being held by the Tioga County Industrial Development Agency, in accordance with the provisions of Article 18-A of the New York State General Municipal Law, with respect to Ithaca Neighbor-hood Housing Services, Inc., or an entity to be formed, via a telephone conference call instead of a public hearing open for the public to attend. Members of the public may listen to the public hearing and comment on the project and the benefits to be granted to Ithaca Neigh-borhood Housing Services, Inc., or an entity to be formed, by the Agency during the public hearing by dialing into the conference call as noted at the bottom of this Notice of Public Hearing. Ithaca Neighborhood Housing Services, Inc., a New York Domestic Not-For-Profit Corporation, or an entity to be formed, (the "Company") has requested that the Agency assist in the financing of the acquisition, construction and equipping of 2.0+/- acres of land situate on Temple Street and Liberty Street in the Village of Owego, Town of Owe-go, Tioga County, New York (the "Land") to be used as an affordable housing development complex consisting of three (3) residential buildings to include 45 apart-ments, and any other directly or indirectly related activi-ties (the "Facility") and the acquisition and installation in the Facility of certain equipment (the "Equipment"). The Land, the Facility and the Equipment are hereinafter, col-lectively, the "Project". The Project will be initially owned, operated and/or managed by the Company. owned, operated and/or managed by the Company

The Agency will acquire a leasehold interest in the Project and lease the Project back to the Company. At the end of the lease term, the Agency's interest in the Project and Equipment will be reconveyed to the Company. The Agency contemplates that it will provide financial assis-tance to the Company in the form of the issuance of ex-emptions from sales and use tax, mortgage tax, and an abatement of real property taxes deviating from the Agency's Uniform Tax Exemption Policy.
