# ECONOMIC DEVELOPMENT & PLANNING TOURISM/AGRICULTURE LEGISLATIVE COMMITTEE MEETING June 8, 2021

Committee Chair, Legislator Dale Weston called the meeting to order at 1:00 P.M.

#### MINUTES

• Approval of minutes from May 4, 2021 – Committee Chair asked for approval of the minutes from the May 4, 2021 committee meeting. Legislator Roberts made a motion to accept the May 4, 2021 minutes, seconded by Legislator Hollenbeck. All were in favor.

Ms. Tinney announced that she will not be at the next committee meeting scheduled for Tuesday, July 6<sup>th</sup>. Ms. Woodburn will be there in her place.

**TIOGA COUNTY CORNELL COOPERATIVE EXTENSON: T Hanson** – CCE Agricultural Highlights report previously emailed, as well as the proposal to buy Cass Hill Farm, the Farm Business Plan and the STREDC Endorsement Letter. Ms. Hanson reviewed her report including the purchase of a farm in Candor and hiring a full time Agriculture Educator. Ms. Hanson requested financial support from the County; \$20,000.00 (half the salary of the Ag Educator position) to be able to attract and hire a quality candidate. After some discussion, it was decided that upon receiving a written plan supporting the request, it could be brought forward to the full Legislature for review.

**ECONOMIC DEVELOPMENT & PLANNING (ED&P): LeeAnn Tinney** – Agenda, attachments and highlights previously emailed. Following are the Director's Highlights:

  - Temple and Liberty LLC– Housing project in the Village of Owego. The cost benefit analysis was sent out this morning. Ms. Curtis will be presenting to the full Legislature on June 10<sup>th</sup>. A special use permit is required to build within the flood plain, no other variances needed.
  - West Bay Star (Lourdes Medical Building)- PILOT request was presented to the Legislature, since then discussion continued of what was needed on this project. It will be brought forward again with a revised cost benefit analysis.

Ms. Tinney reported one more application coming in. After that, when the Loan Committee meets again there will be a discussion for recommendation to close the program and return the funds back to the HUD Account.
