2023 Program Highlights

Back to School Immunization Campaign

Over the summer, our department did a targeted campaign to remind parents and guardians to make sure their children were up to date on their immunizations before the 2023 - 2024 school year began. Through this campaign we ran a television commercial, had lawn signs up at all six school districts, and ran newspaper and social media ads.

Every year, students are excluded from school because they are missing one or more doses of vaccinations that are required for school attendance. Our nurses and staff work with parents to promptly get needed vaccines either administered at our clinic or at available providers. This timeliness assures that the number of children excluded is minimal.



Creating Healthy Schools & Communities Grant

Through this grant, we work with municipalities, school districts, and food service locations to help establish and support healthy communities where it is easier to practice healthy behaviors.

Year 2 Showcase Project - Nichols Park

Village of Spencer

Our biggest project from Year 2 of the Creating Healthy Schools & Communities Grant was done in collaboration with the Village of Spencer. This project was completed with additional funding sources that the Village sought out to redo the walking trail around Nichols Park to ensure that the trail was ADA compliant. Our staff communicated frequently with those involved with the project, including the main contractor completing the work, to ensure that all purchases were grant approved. This project was a great representation of how these funds can help a municipality increase safe and accessible physical activity.

2023 Program Highlights

Opioid Overdose Prevention Program

Save A Life - Free Narcan Day

Tioga County Public Health in partnership with Tioga County Mental Hygiene, CASA-Trinnity, and the Tioga ASAP Coalition partnered for the first Save A Life - Free Narcan Day in Tioga County!

Over a two day span, six Narcan distribution and training sites were set up at <u>Tioga Downs Casino</u> <u>Resort</u>, <u>Resource Center of Candor Bread of Life</u> <u>Food Pantry</u>, <u>Spencer - Van Etten Food Cupboard</u>. <u>The Red Door</u>, <u>Tioga County ASAP</u>, and <u>Village of</u> <u>Newark Valley</u>. In total, 84 Narcan Kits were distributed across Tioga County!

Public Access Narcan (PAN) Boxes

The Tioga County ASAP Coalition worked hard to expand the Public Access Narcan Box program in 2023. Twenty-six new boxes were installed in various locations around the county including local libraries, non-profit agencies, motels, and more, increasing the total number of PAN Boxes in Tioga County to 31! PAN boxes help make Narcan publicly accessible for anyone who may need it for themselves or someone else in their lives.

Through this program, we have also been able to offer opioid overdose prevention trainings. Community members learn how to use Narcan to respond to an overdose and are aware of the purpose of the PAN boxes, so that they may encourage others to utilize them as needed!

Welcome Baby Outreach

This year, our team reintroduced our Welcome Baby Outreach, a program that has been on pause since the pandemic began. Each week, one of our health educators reviews a list of births for Tioga County so that a warm welcome packet can be sent to our newest residents. Baby books, growth charts, and more are mailed directly to one's home.

Mothers who are listed as high-risk due to pregnancy complications, teenage mothers, and other circumstances, may receive a phone call to inform them of additional resources available to support their family.

Unfortunately, any births that occur outside of New York State (most frequently at Robert Packer Hospital in Sayre) are not reported to our department in the same way, making it more challenging to reach our highrisk families. We hope to have a solution to this in 2024!







Public Health Open House

On April 20, 2023 our department came together to hold an Open House. All of Tioga County, including county departments, partner agencies, New York State affiliates, and community members were invited. Around onehundred guests attended the event!

We were able to give tours of our on-site therapy room, Mobile Dental Van, showcase the programs we offer, and all of the work we do in Tioga County.

The theme of our Open House was:

- Reset as a department
- Renew our partnerships
- Reimagine public health in Tioga County

Coming out on the other side of the COVID-19 pandemic, this event was a great opportunity for us to share the amazing work that our department does for our community!

2023 Success Stories

On-Site Therapy Room for Children

Children's Services has continued to navigate the shortage of providers available to children who are enrolled in Early Intervention. The onsite therapy room, which was created in 2022, has been well utilized. The room provides a solution to transportation barriers and scheduling conflicts. When a therapist utilizes this space, it allows them to see more children by removing the time it typically takes to travel from location to location to meet with families.

In 2024, the team is hopeful to announce additional solutions to ensure that those who need Early Intervention are able to receive these services.



Well Head Replacement Grant

Tioga County Public Health has served as a pilot project for New York State with our Well Head Replacement Program. The objective of this project is to address the issue of individual water wellheads that are at risk of contamination and subsequent health problems. The program goes beyond water sampling and addresses barriers to replacing wellheads. In 2023, this grant was able to assist with replacing or repairing 18 well heads for Tioga County homes!

Groundwater is the primary source of drinking water for most Tioga County residents. Due to the importance of the work, the project will be expanding in 2024. This program has become an essential component of the county's public health initiative. The pilot project has received additional funds to include ultraviolet and chlorination disinfection systems, and funding for excavation projects.





Dental Services



In October 2023, the Tioga Smiles Dental Program celebrated 20 years of serving Tioga County!

It was another busy and successful year serving all 6 school districts and the Tioga County community!

Dental Health Fair

In May 2023, the Tioga Smiles Dental team, Tioga County Public Health and partner agencies, CASA-Trinity and Cornell Cooperative Extension, all participated in a Dental Health Fair Day at Van Etten Elementary School.

Stations were set up for students to learn about:

- Proper brushing and flossing tips
- · What you eat impacts your teeth
- · How much sugar is really in your drink
- · Habits and the impact on oral health

Tours were also given to each class on the Mobile Dental Van with the hope that a glimpse of the van would alleviate any future fear of going to the dentist!

Overall, it was a very successful day! Students left with new toothbrushes and a water bottle with messaging reminding them to choose plain water over sugar sweetened beverages.

Patient Services

Lead Poisoning Prevention Program

Our Lead Poisoning Prevention Program has been hard at work, revamping and improving how the program operates. Lead is a collaborative program, bringing together our health educators, public health nurses, and public health sanitarians, to investigate cases of lead poisoning in children.

Children should have their blood tested at ages 1 and 2 to determine if they have elevated levels of lead in their blood. Due to the old housing stock in Tioga County. which includes many houses that still have lingering lead paint, as well as other factors such as polluted soil. we do see children with elevated lead levels. As of December 2023, 31 children with elevated lead levels were being followed by our team for care coordination and environmental health services.

This year, we partnered with 12 restaurants around the county to deliver crayons and coloring placemats with lead poisoning prevention education. Education was also done through social media and billboard messaging.

After almost two years without a nurse on our staff, one of our most exciting updates from 2023 is that we were able to recruit two nurses to join the team as a Public Health Nurse and Director of Patient Services. Adding nurses back on to our staff has allowed us to get back to one of the most important aspects of public health - immunizations!

Our clinic staff is now able to assist with:

- Vaccinating children and adults who are uninsured, underinsured, or have Medicaid for insurance
- Looking up vaccination history (if requested by the individual)
- Answering general guestions about immunizations
- Recommending vaccines for specific life stages to offer maximum benefit (children, pregnancy, older adults, etc.)
- Planning for future/upcoming vaccinations
- Ensuring school-aged children have all recommended vaccines to attend school or davcare

Environmental Health

ATUPA Program

(Adolescent Tobacco Use Prevention Act)

Did you know that in May 2020, a ban was put into place in New York State on the sale of flavored vapor products that do not have an FDA marketing order? This includes menthol and fruity flavored products. Flavors, like fruit, candy, and chocolate are largely responsible for the dramatic increase in use of e-cigarettes by youth and are a principal reason that vouth initiate and maintain e-cigarette use.

In October 2023 a retailer within Tioga County was caught illegally selling flavored vaping product. This type of violation comes with a mandatory fine. The illegal sale of tobacco products, such as flavored vaping products or the sale of any tobacco products to those under 21, may be





REPORT AN ANIMAL BITE

This year we launched a new online fillable form for individuals to report bites and scratches from both wild and domestic animals. Regardless of the animal's vaccination status, an animal bite should be reported as soon as possible so that our team can investigate the incident's circumstances to determine if Rabies Postexposure Prophylaxis treatment is necessary.
