MEETING MINUTES July 21, 2022

CALL TO ORDER: 7:33 a.m. by Dr. Picco

INTRODUCTION OF GUESTS:

Dr. Picco introduced Ms. Olevano and Ms. Holochak, presenting on topic of E-Cigarettes, Vaping, and the Impact on Tioga County Youth. Ms. Olevano explained her professional background in health education/substance abuse prevention.

PRESENTATION:

- Ms. Olevano handed out an initial quiz sheet, for the Board to complete, with general questions about vaping and E-Cigarettes. She provided all answers to questions with brief explanation.
- Proceeded with a power point presentation covering:
 - Statistical data on vaping collected by Alcohol and Substance Abuse Prevention Coalition, both nicotine and marijuana, in Tioga County School Districts targeting youth population (grades 8, 10, and 12).
 - Results show an increased use as the children get older.
 - Reasons why teens vape:
 - Youth-targeted marketing
 - Accessibility
 - Social norm
 - Addictive
 - Perceived as being low risk
 - Samples of vaping devices (Puff Bar, Suorin Drop, Vuse)(examples were passed around to members)
 - o On the horizon, predicting will see bigger issue of cannabis vapes in youth.
 - Solutions: youth led initiatives, county wide initiatives, and school consistent policies.
- Dashboard created to show data taken from the school surveys, link to dashboard will be sent to Board.
- If interested in this initiative, always looking for people to join the Substance Abuse Coalition.

OLD BUSINESS:

- Meeting Minutes: Motion to approve prior minutes made by Dr. Hills; seconded by Dr. Kapur-Pado; no discussion, all were in favor, motion approved.
- Enforcements:
 - o Ms. McCafferty briefly explained reasons for water/food stipulations.
- Stipulation Policy: Ms. McCafferty handed out hardcopies of the final draft of the stipulation policy to the Board, which incorporated feedback from Board of Health and Division of Environmental Health.
 - Requested Board review, and any further feedback; goal is to present final for vote at September meeting.
 - Dr. Picco inquired if there has to be an official reading of the policy for the minutes to acknowledge it has been read by the Board. Attorney DeWind answered that there does not have to be an official reading, based on the nature of the document.
 - Dr. Kapur-Pado asked who determines the fees within the policy. Ms. McCafferty explained that it is the policy itself that determines the stipulation amounts. During revision, these were increased.

NEW BUSINESS:

- Board Membership: Ms. McCafferty reminded the Board of Mr. Millar's email, declining to renew his Board of Health term, which ended July 12, 2022.
- Attorney DeWind explained that discussion of the number of members of the Board needs to take place. Per Tioga County's Health District created in 1985, under New York State Public Health Law 343, the Board of Health should be made up of seven members, one of whom is a legislator and three physicians. Through regular attrition, can decrease membership back to seven.
 - o Dr. Picco inquired who would be the next member with term expiration.
 - Dr. Nytch expires in December of 2022, Dr. Picco expires December 2023.
 - Dr. Picco stated that he would be willing to step down before Dr. Nytch and have Dr. Nytch complete his term until December 2023.
 - Dr. Picco asked the Board if the topic of Board membership could be topic for meeting in September, so that it would not be rushed; Board agreed.
 - Dr. Raftis asked how beneficial would it be for the Board of Health to decrease numbers to seven; for the purpose of meeting quorum, having a well-rounded board, etc.
 - Dr. Hills asked Attorney DeWind if Board members are to be Tioga County residents. Attorney DeWind stated that members are to be Tioga County residents.
 - The official statute will be included in September Board packet.

INFORMATIONAL:

- Board received the Agency Report electronically. Dental Van summary notes were included, reporting Tioga County school district data for the 2021-22 school year. Brief discussion about dental care availability, leading dental issues.
- Ms. McCafferty informed the Board about Sundaes at the Farm event taking place in Newark Valley, Sunday July 24th in Newark Valley. Public Health will be at event promoting Community Health Assessment.
- Ms. McCafferty handed out New York State Department of Health advisory on Monkeypox, Monkeypox talking points, and promotional flyers for Monkeypox. She explained that Monkeypox is receiving a lot of media coverage. Notified of individual cases in surrounding counties, but predominantly in metro/New York City area.
 - Seeing "COVIDIFYING" of Monkeypox: contact tracing, beginning of vaccine dissemination, concerns about mutations.
 - Physicians are frustrated because the disease mimics other symptoms.

- o Dr. Nytch commented that it is now "Smallpox Light," could spread fast.

NOTEWORTHY ITEMS, UPDATES AND ACCOMPLISHMENTS

- Received \$19,400 grant for well sampling and repair for private wells and smaller water systems from New York State Department of Health.
- Meagan Ferguson was nominated as Employee of the Second Quarter for 2022!
- The Tioga Dental Van received Facebook feedback from a community member: "Thank God for The Tioga Dental Van. Great people and excellent service. I couldn't afford to go to the dentist if it wasn't for them. THANK YOU!!!"
- Provider shortage continues in Early Intervention (EI) and Preschool. We received nine new referrals this month; twelve children remain waiting for services.
- Hosted Community Health Assessment (CHA) Steering Committee meeting to discuss status of CHA and Community Health Improvement Plan (CHIP) and promote CHA survey for the public. Members of the internal CHA Steering Committee have been attending local farmer's markets, food banks, town/village halls, local businesses and community events, including *Tioga County Annual Kids Picnic* at Marvin Park and *Sundaes at the Farm* in Newark Valley, to distribute the CHA survey and encourage participation. We currently have 788 responses. Goal is 800. Survey closes July 31st.
- "Tick Kits" were distributed to all town and village halls.
- Public Health Educators (PHEs) collaborated with DSS to facilitate a Child Passenger Safety Training for Child Protective Services.
- Laura Bennett, hosted a Lunch & Learn Session for county wellness and invited guest speaker from Cornell Cooperative Extension (CCE) to speak on "Eating Healthy On a Budget".
- Launched internal "Work Force Development" survey as part of Project Public Health Ready; for Emergency Preparedness, to assess training needs of our department.
- PHEs toured CCE's new farm in Candor and discussed ways we could partner in the future.
- Angel Conklin & Katie Wait assisted Broome County Public Health with a "Car Fit" Safety Event
- Emergency Preparedness Coordinator distributed info on Monkeypox to Primary Care Providers, Emergency Medical Services/First Responders and community agencies
- The Marvin Park pool passed inspection for use for the summer.
- Dan Scherrer attended the Village of Candor Water Project meeting, the subject of which was the new main water line installation occurring in late July and August 2022. Dan discussed disinfection of the main lines and how to proceed with food service and residential water interruptions

- In process of updating department policies; including the Environmental Health Penalties/Violations policy which is in final draft review, with internal and Board of Health input.
- We said goodbye to Ashley Coney, and wished her well in her future endeavors.

2. During 2020, the Legislature required a 10% cut in expenses from all County departments. This was removed from the Expense side of the ledger, but not the offsetting revenue portion, thus inflating the reported "Local Share" of Public Health by nearly \$375K.

3. COVID Specific funds have been removed from these tables, as they skew the numbers due to their large amounts. Currently over \$2.6 million has been appropriated of Covid funding within Public Health.

Public health educator Heat-related illnesses are

caused by extreme heat events and occur when the body is unable to cool itself. The most common heat-related illnesses are heat stroke (sun stroke), heat exhaustion, heat cramps. and heat rash.

Between May and September of 2019, heat-related illness sent 1,256 New Yorkers to the emergency room and hospitalized 133 (data excludes New York City). Follow these steps to avoid, spot, and treat heat-related illnesses.

Avoid: Tips to Beat the Heat!

Check on friends and neighbors at high risk for heat-related illness: infants. young children, older adults, and people with chronic medical conditions.

Drink plenty of fluids, but avoid alcohol, caffeine. and sugary drinks.

Avoid, Spot, Treat

Extreme Heat:

NEVER leave people or pets in closed, parked vehicles (even with the windows cracked).

Wear loose, lightweight. light-colored clothing to help keep cool. Don't forget sunscreen and a ventilated hat, even if it's cloudy out! Take breaks often and

avoid strenuous activity during the hottest part of the day (between 11 a.m. and 4 p.m.).

Spot: Signs of Heat-Related Illness

Heat stroke and heat exhaustion have many similar symptoms such as dizziness, headache, upset stomach or vomiting, and fainting or passing out; however, the differences can help distinguish what type of heat-related illness the person is experiencing. Heat Stroke signs

include a body temperature above 103°F; red, hot, dry skin (no sweating); rapid, strong pulse; and confusion.

Heat Exhaustion signs include heavy sweating, paleness, muscle cramps, tiredness, and weakness.

If you see any of these signs, seek medical help

Stay out of the sun and immediately. in an air-conditioned loca- Treat: What to Do While Waiting for Help

If you think someone might be experiencing a heat stroke, move them to a shady area or move them inside. Do not give them fluids. You can help cool the body by placing the person in a cool (not cold) bath or shower, spraving them with a garden hose or sponging their body with cool water, or by fanning. Continue efforts to cool the person until help arrives or their body temperature falls below 102°F and stays there.

If you think someone might be experiencing heat exhaustion, get medical attention if symptoms get worse or last longer than one hour. Cool the body with cool, nonalcoholic beverages; a cool (not cold) bath, shower, or sponge bath; and move them to an air-conditioned room.

Seek medical help immediately if symptoms are severe or if victim has heart problems or high blood pressure.

Tioga County Health Department: Stay safe in the sun

sun safety practices!

While it is important to spend time outdoors, we should be mindful of protecting our skin from sun damage.

In as little as 15 minutes the sun's UV rays can burn the skin; you can still get a sunburn on cool, cloudy days.

Practicing sun safety is important because overexposure to sunlight can lead to skin cancer, the most common (yet most preventable) form of cancer in the United States.

Follow these sun safety tips to protect your skin this summer:

Apply sunscreen with at least 15 SPF, and reapply every two hours and after swimming

Seek shade under trees, umbrellas, or other forms of shelter

 Wear long-sleeved shirts and long pants - keep in mind that dark, tightly woven materials offer the most protection

· Wear a hat with a brim wide enough to cover your head, neck, and ears

 Wear sunglasses that have UVA and UVB protection

 Limit time outside between 10am and 4pm when the sun's

rays are strongest

The most dangerous form of skin cancer is Melanoma.

Regular skin checks are crucial detecting for and treating Melanoma and other skin cancers early.

Home skin-checks can be completed using the ABCDE method of identifying concerning moles:

ABCDE Method:

 A - Asymmetry, one half does not look like the other

 B - Border, jagged, scalloped, or uneven borders

 C - Color, contain different colors or are a strange color (blue, black)

· D - Diameter, larger than the size of a pencil eraser (6mm)

· E - Evolving, changes over time (grows larger, changes color)

If you or a loved one notice a strange freckle or mole that fits at least one of the ABCDE criteria, schedule an appointment with your primary care provider, or a dermatologist, as soon as possible.

Guest column: No time for Lyme

With the arrival of warm weather, ticks are out there and can make their way to infect people or animals with Lyme disease.

In 2019, New York State had 2,847 confirmed cases of Lyme disease, of which 30 were residents in Tioga County.

The case count is likely higher since many cases remain undiagnosed, and because Tioga County is a sentinel county, meaning only a small percentage of Lyme disease cases are investigated.

Lyme disease is a bacterial infection that is transmitted to humans through the bite of infected blacklegged ticks, also known as deer ticks.

It is important to note that not all ticks transmit Lyme disease.

Symptoms usually develop within three to 30 days and may include: fever, chills, headache, fatigue, muscle and joint pain, and/or a bull's-eye rash.

Serious health complications can occur if Lyme is left untreated, so it is important to be attentive if a tick bite occurs.

Early treatment of Lyme disease involves antibiotics and almost always results in a full recovery. However, the chances of a complete recovery decrease if treatment is delayed.

In today's busy and demanding world we do not have time for Lyme! Take these steps to protect against ticks:

• Avoid grassy, brushy, or wooded areas with high leaf and grass litter

o If you are out in these areas, wear long-sleeved, light-colored clothing especially in highly wooded areas, and walk in the center of trails

• Treat boots, camping gear, and clothing with products containing 0.5% permethrin

o Permethrin is an insecticide in the pyrethroid family. Pyrethroids are synthetic chemicals that act like natural extracts from the chrysanthemum flower.

• Use insect repellent containing DEET, registered by the Environmental Protection Agency (EPA)

• Examine pets, clothing, and gear for ticks

· Carefully check your body for

ticks and immediately shower after coming indoors

If you have been bitten by a tick, remove it as soon as possible. Use fine-tipped tweezers to grasp the tick as close to the skin as possible. Pull upward with even, steady pressure. Do not twist or jerk, as this can cause the mouthparts of the tick to break off and remain in the skin.

After removal, clean the bite area with rubbing alcohol or soap and water. Lastly, dispose of the tick by placing it in alcohol or a sealed bag, wrapping it tightly in tape, or flushing it down the toilet.

Never crush a tick with your fingers.

Never use dangerous methods, such as fire, to remove a tick.

If you are experiencing any symptoms of Lyme disease, please contact your primary health care provider.

New York State has a free tick testing program, in Syracuse, for ticks captured in NY. Since 2021, 179 ticks were tested in Tioga County and 59 were positive for Lyme disease. More information about the free testing program can be found by visiting nyticks.org. Tiope & Owner 7/13/22

WHEREAS: By knowing the signs of Lyme disease, treatment can be started early to avoid long-term complications of Lyme disease; and

WHEREAS: The residents of Tioga County can recognize the threat that Lyme disease has to them and their family; therefore

Legislature approves Veterans Service Assistant

At the August 9 regular meeting of the Tioga County Legislature; the legislature approved the hiring of a full time assistant to the Director of Veterans Services.

The Tioga County Veteran Services' Agency (TCVSA) has received new state aid for the Dwyer Program sand has a need to hire a full time assistant to both provide administrative assistance and act as back up to the agency's officers.

Legislative Chairman Martha Sauerbrey commented on the excellent work the TCVSA is doing in helping Tioga County's Veterans.

The legislature approved amending the 2022 budget and transferred funds and also approved a change order for the Park Settlement Bridge.

This bridge is in need of repair work according to the NYSDOT. Economy Paving Corp was awarded the construction contract in June; and now an order for additional work has been submitted.

Funding for \$90,000 was approved from the fund balance, moved into the Park Settlement Bridge account.

Legislator William Standinger noted, "I believe the Park Settlement Bridge is the longest wooden bridge in New York State; and appreciate it being kept open as the other bridge on that road is worse and this one is needed

Tiega Courty Courier 8/17/22 for emergency services to get to them ar residents, if needed."

The Park Settlement Bridge is located in Standinger's district. The Tioga County Public Health

(TCPH) has been awarded funding from the NYS Department of Health.

The funding originated from the Centers for Disease Control, and that funding, in the amount of \$19,400, is designated for a "Priot budget. Program for Protecting Vulnerable Rrivate Wells and Smaller Water Systems."

The Department of Motor Vehicles has a need for a Customer Facing Device for the new workstation in the office; and NYS DMV requires that any computer hardware used in DMV transactions be purchased from

them and has a set price for the new equipment at \$4,094.

The legislature amended the DMV's budget and approved the purchase.

The Assigned Counsel Administrator's Office has been awarded an Indigent Legal Services Grant in the amount of \$61,902; and the legislature accepted and amended their

A resolution was passed amending for an additional cost of \$133,020.84 for the additions to the computer Aided Dispatch (CAD) Project add Owego Police to CAD: Digital Evidence Module for Owego Pictometry for Mapping; Rapid Notification Module and Data Transfer Costs.

Swimming Safety

Swimming is an excellent way to be physically active during the hot summer months. However, it is important to take precautions while enjoying time in the water to prevent illness, injury, and even death. According to the Centers for Disease Control and Prevention, drowning is a leading cause of death among children ages 1-4 years. Furthermore, illnesses can be spread if people enter the water while sick with gastrointestinal symptoms, such as diarrhea. The good news is there are steps you can take before, during, and after swimming to protect yourself and your loved ones. Before Swimming

· Check for lifeguards. If no lifeguards are on duty, locate the safety equipment (ex. life preserver ring).

• Apply sunscreen with at least 15 SPF. Reapply every hour as sunscreen is not waterproof!

· Ask a friend or family member to accompany you. Never swim alone. Make sure the water looks clean and is not cloudy or discolored.

· Do not go in the water if you are sick with diarrhea.

• Do not go in the water if you have an open wound or cut that is not completely covered with a waterproof bandage.

 To avoid slipping and falling, do not run around the pool deck. While Swimming

· Keep an eye on children at all times. Avoid distractions while supervising.

· Have young children or inexperienced swimmers wear lifejackets.

· Do not dive or jump into shallow water.

• Do not dive or jump if someone is in the area where you will land.

· Do not swallow the water.

Take kids on bathroom breaks and check diapers every hour.

· Stay hydrated.

• After Swimming Dry your ears to help prevent swimmer's ear.

· Keep hydrating. Swimming can lead to dehydration as it is harder to recognize how much fluid you are losing. You can still sweat while in the water!

First Case of Monkeypox Identified in Tioga County

Tioga County Public Health has confirmed its first case of monkeypox in the county. The department confirms this is an isolated case and there are no associated close contacts. There is no health risk to the general public at this time. Tioga County Public Health is encouraging residents to be aware of the symptoms and take steps to reduce the risk of contracting the infection. Martha Sauerbrey, Legislative Chair says, "Residents do not need to feel alarmed. and she has complete confidence in Tioga County Public Health to manage the situation."

Monkeypox spreads through close physical contact between people.

This includes:

- · Skin-to-skin contact with monkeypox sores, rashes, or lesions
- · Skin contact with fabric or dressings that have contacted sores, rashes, or lesions
- Sexual activity with single and/ or multiple, partners that have monkeypox
- Prolonged, face-to-face contact where respiratory secretions are shared



Tioga County Public Health is encouraging residents to be aware of the symptoms of monkeypox and take steps to reduce the risk of contracting the infection.

Symptoms of monkeypox include:

· Rashes, bumps, or blisters on or around the genitals or in other areas like hands, feet, or face, which are not clearly due to something else

 Potential flu-like symptoms such as fever, aches and pains, fatigue, and chills

It's important to note an individual may experience all or only a few symptoms. The disease is contagious from the onset of symptoms or until the rash scabs have dried up and fallen off and the skin is healing well underneath.

Community members can reduce the risk of monkeypox by avoiding close face-to-face and skin-to-skin contact with someone who has a monkeypox-related rash or other symptoms, avoiding traveling to areas where monkeypox is present, and asking sexual partners if they have a rash or symptoms consistent with monkeypox.

If you are concerned about your risk to monkeypox or are experiencing symptoms, you should contact your primary care provider to assess your condition and help you take the appropriate next steps. A vaccine is available for those with high risk of infection, and antiviral medications are available to the infected. How Does Monkeypox Spread?

• Direct, physical contact with someone who has monkeypox sores.



- Respiratory droplets or oral fluids from someone with monkeypox.
- Contact with objects or fabrics (clothing, towels, bedding) that someone with monkeypox used.

How Can I Protect Myself?

- Ask sexual partners if they have a rash or other symptoms consistent with monkeypox.
- Avoid skin-to-skin contact with someone who has a rash or other monkeypox related symptoms.
- If you are exposed to monkeypox or are experiencing symptoms, reach out to your health care provider.

School Bus Safety

Riding a school bus is the safest way for your child to get to school. Review when to approach the bus, how to behave on the bus, and bus stop safety.



Walking to School

Whether your child walks alone or with a friend, make sure you discuss the route they take, how to cross the street, and what to do if someone they don't know approaches them.

Bicycling to School

Make sure you review bike safety including wearing a helmet, the safest bike route, and rules of the road.

Discussing Threatening Situations

Talk about being aware of what is around them, who to trust and what to do if someone approaches them. Teach your child how to identify a harmful situation, create a no-secret policy, and make sure your child memorizes your phone number!

COUNTY OF TIOGA EXECUTIVE PROCLAMATION

WHEREAS: August is National Immunization Awareness Month with immunizations representing one of the greatest public health accomplishments of the 20th century; and

WHEREAS: If following the recommended immunization schedule, immunizations give parents the safe, proven power to protect their children from serious communicable diseases. However in 2020, less than 50% of children in Tioga County aged 24-35 months received their recommended vaccine series, compared to over 60% of New York State; and

WHEREAS: Child care facilities, preschool programs, schools and colleges are prone to outbreaks of infectious diseases due to poor hand washing, not covering coughs, and other factors such as interacting in crowded environments; and

WHEREAS: The release of immunizations for COVID-19 has reiterated the importance of educating the public on the benefits of vaccination to reduce rates of missed school and work, and rates of severe illness and/or death from the novel coronavirus; and

WHEREAS: Immunizations are an important part of a healthy pregnancy and allow the mother to pass some protection on to her baby. Women should be up to date on their immunizations before becoming pregnant and should receive immunizations against both flu and whooping cough during pregnancy; and

WHEREAS: All adults should get immunizations to protect their health. Even healthy adults can become seriously ill and pass diseases on to others. Everyone should have their immunization needs assessed at their primary care provider's office; therefore
