Committee Chair Barb Roberts called the meeting to order at 1:00 P.M.

ECONOMIC DEVELOPMENT & PLANNING (ED&P): Agenda and attachments previously emailed.

I. MINUTES

A. Approval of minutes from May 7, 2024 – Committee Chair Roberts asked for approval of the minutes from the May 7, 2024, committee meeting. Legislator Ciotoli made a motion to accept the minutes from the May 7, 2024, meeting, seconded by Legislator Flesher. All were in favor.

Ms. Woodburn reported the following:

II. FINANCIAL

- A. 2024 Budget Ms. Woodburn reported the following:
 - 1. Economic Development
 - Year-to-Date Budget is tracking.
 - 2. Planning
 - Year-to-Date Budget is tracking.
 - 3. Sustainability Management
 - Year-to-Date Budget is tracking.

III. OLD BUSINESS

- A. Reports
 - Tioga County Tourism Becca Maffei, Tourism Director; monthly report previously emailed. Ms. Maffei distributed an updated report and reviewed the 2024 Content Project, Recruitment Website, Event Promotion, Travel Guide, and Tioga Antiques Trail.

Not on her report, Ms. Maffei reported the desire to put a sign on the highway directing traffic to the Tioga Antiques Trail. When speaking to DOT it was suggested to put together a packet to justify putting a sign up on the highway. Ms. Maffei would like to include letters of support in the packet and asked this committee to consider having the Legislature provide a letter of support for this project. Ms. Maffei indicated she will be requesting letters from Rotary, Kiwanis, the Chamber, but pointed out a letter from the County Legislature may have more impact. Legislative Chair Sauerbrey asked Ms. Maffei to draft a letter and send it to her, then suggested Ms. Maffei attend the Worksession to answer any questions.

- 2. Tioga County Soil and Water Conservation District Ms. Walsh, Tioga County Soil and Water, did not send a monthly report, however she did send the Soil and Water Annual Report to be disbursed.
- 3. Tioga County Cornell Cooperative Extension (CCE) Monthly report is in the committee packet.
- 4. Economic Development In keeping with staff reporting, Ms. Woodburn introduced Megan Schnabl, Deputy Director, Economic Development and Planning. Ms. Schnabl reported the following projects: DRI Projects:
 - 37-41Lake Street (Gallery 41) Working on the store front and coordinating with the architect for drawings for apartments on second and third floor; project is moving along.
 - 53-55 North Ave Project complete and submitted for final reimbursement.
 - 62-64 North Ave- Just getting started on the storefront.
 - 48-50 Lake Street (Tioga Trails Building)- Continue to work with property owner to complete all required paperwork; possible RFP for environmental work.
 - Ti-Ahwaga- Project is going well; porch project complete. Looking to sign with an electrician for electrical upgrades.
 - 43-45 Lake Street (Owego Antique Center)- Work with contractor to begin work on new doors, entry way, porch and roof.

New DRI Multi-site Fund Projects- Remaining funds awarded last year:

- 187 Main Street (Kathy Cakes)- Going for a site visit to see progress on this project.
- 68 North Ave (Anything Artistic)- Deck complete, waiting for window installation.
- Elks Lodge- Replacing roof over emporium section of building; coordinating with contractor for asbestos abatement as well as working with a roofing contractor.
- 130 Temple (backside of 231 Main St)- Project complete by end of July; seven new apartments.

<u>CDBG</u>

- Neighborhood Depot- Submitted for another reimbursement, leaving less than 1M more to draw from their 3M grant.
- Microenterprise Grant-Submitted final documents to the consultants, Thoma Development, to submit the application, this is a rolling application, no deadline.

Restore NY Projects

- Fuddy Duddy's (River House Confectionery & Mercantile)- They continue to work with their lender; submitted a new business plan due to the bank needing updates.
- Submitted two Restore NY Round VIII applications:
 - Tioga County submitted one for Land Bank properties; rehabilitation of 81 North Ave. and reconstruction of 5 single family homes on Liberty and Temple Streets.
 - Village of Newark Valley Two buildings on Whig Street; assisted the property owner and the Village of Newark Valley with paperwork for application.
- Ms. Woodburn continued to report:
 - B. Grants
 - 1. Active Grants See attached EDP Grant Tracking spreadsheet.

Ms. Woodburn reported going forward all grants will be listed on a spreadsheet instead of listing them on the agenda each month. The top portion are the grants that Tioga County is the applicant and lists their progress. The bottom portion are the grants that the County is not the applicant; that the staff was a resource or that we provided technical assistance. The committee did like the spreadsheet way of reporting and asked that it be included with the minutes.

Recommended by this committee, the two listed on the spreadsheet that ED&P provided technical assistance on will go on a late resolution to go before the Worksession.

- C. Economic/Community Development
 - 1. Village of Owego DRI- Ms. Schnabl reported earlier on the active projects.
 - 2. Village of Waverly NY Forward projects announced. Ms. Woodburn created a list of the projects with descriptions. The list was distributed. Ms. Woodburn reported that it will take some time for contracts to be issued.
 - 3. Broadband STN MIP grant application
 - a. Application submitted March 4, 2024
 - b. Announcement anticipated May 2024

Ms. Woodburn reported the incentive proposal is expected soon. Once awarded the build out will include additional parts of Nichols and expand to Newark Valley and Smithboro. No participation is expected from us.

- D. Land Bank
 - 1. 10 Watson Avenue, Newark Valley– Rehabilitation almost complete, about three weeks left and will be sold as a single-family home; 4 bedrooms, three bathrooms. Once sold, the property will be back on the tax roll.
 - 2. 121 Providence Street and 32 Lyman Avenue in Waverly Rehabilitation in process.
 - 3. 81 North Avenue, Owego- A 3-story mixed use building; demolition and clean out is aging on this week.
 - 4. 247 Main St, Owego Rehabilitation to start later this summer.
 - 5. Temple/Liberty Street, Owego Land Bank Board agreed to finalize the subdivision plan for single family homes. Will begin to seek funding sources for construction.

- E. Workforce Development Mr. Lanning continues to work on the following:
 - 1. Business Leads Fellowship Program-Attended the following sessions:
 - a. Chronic Absenteeism session
 - b. College and Career Readiness session
 - 2. Talent Supply Table Managing the three committees for this group; coordinating the 2nd annual meeting in August.
 - 3. School/Career Center Pilot Program- In Waverly and Spencer schools; collecting data from the Career Center to see how the program went. Will be reaching out to other school districts to see if there is any interest in participating.
- F. Planning
 - 1. Hazard Mitigation Plan update Homeland Security and FEMA has approved the plan. Ms. Jardine distributed a template adoption resolution to the municipalities and has heard back from eight municipalities. The Legislature also needs to consider adopting the plan. The resolution is listed below.

IV. NEW BUSINESS

- A. Reports
- B. Grants
 - Potential See attached EDP Grant Tracking spreadsheet. Listed on the spreadsheet, Ms. Woodburn reported the following:
 - Talking to Catholic Charities about doing a Community Development Block Grant for their mobile kitchen. The resolution is listed below to set the public hearing, a requirement for the program. There is no match requirement; possible \$200,000.00 project. Noting there will be an administrative fee.
 - Under technical assistance, the Town of Nichols reached out and is looking to do a Town Comprehensive Plan and Ms. Jardine will be assisting them with the application. This will be listed on the technical assistance resolution mentioned above.
 - The Town of Berkshire is looking to create a Master Park Plan for George W. Smith Park. ED&P staff has identified resources and local foundations to support them.
- C. Economic/Community Development
 - ESD Small Manufacturer Modernization Grant Program- This is a new program geared towards small to mid-size manufacturers for capital projects and equipment purchases. This program will not have job creation tied to it, as they usually do; making it easier for a manufacturer to access. Information was sent out and have had two, possibly three responses looking to apply.
 - 2. CDBG Small Business Grant Program-Looking into this program for another manufacturer.
 - 3. Town of Berkshire, George Smith Park Master Plan Ms. Woodburn spoke about this earlier, but wanted to mention that she and Ralph Kelsey traveled to Berkshire and met with the Town Supervisor, to look at properties for the Land Bank on Railroad Avenue.
 - 4. Pro-Housing Community Program- Mr. Lanning and Ms. Woodburn are getting the word out on this program; attended several meetings:

- a. Town of Berkshire application in process
- b. Attended Village of Newark Valley meeting Has agreed to become a Pro-Housing Community.
- c. Attended Council of Government meeting
- d. Sent information to Village of Nichols

Ms. Woodburn explained this program is the Governor's initiative to try to address housing shortages and crises in NYS. If upstate municipalities can prove and submit documentation that they have increased their housing stock by .33% in one year or 1% over a 3-year period they qualify to be considered a Pro-Housing Community. If communities cannot prove this housing growth, they have to pass a resolution with a Pro-Housing Communities Pledge to meet the requirements. If communities don't participate in this program, they will not be able to access NY Main Street, Restore NY, NY Forward or DRI programs to mention a few. Mr. Lanning has put together a presentation and Ms. Woodburn will send it out to anyone interested on this committee.

D. Land Bank

1. NYMS application for 62-64 North Avenue, Owego is being considered.

- E. Workforce Development Mr. Lanning is working on the following:
 - 1. Manufacturing Day Attended a coalition meeting to get Tioga County schools invited to next fall's activities.
 - 2. Coordinating potential Local Career Panel Circuit with Tioga County schools Facilitating the connection between Owego, Candor, and Newark Valley. Waverly has their own Career Panel Circuit that they do with GST BOCES.
 - 3. Home Central Trades Day on May 14th All Tioga County Schools attended. Over 70 students attended; a successful event.
- F. Planning
 - 1. Susquehanna Heritage Area Management Plan update-Broome County is looking to apply for a CFA to update the plan. The original plan was from 2009 and Tioga County was part of that plan. They are estimating the cost to be \$200,000.00. They are seeking funding from ESD for \$100,000.00, they will provide \$85,000.00 through matching funds and in-kind services. They have asked if ED&P and Tourism would consider participating. Tourism is looking into providing a \$5000.00 match and inkind services. Ms. Woodburn will bring a proposal to this committee next month for ED&P to contribute a \$5,000.00 match, adding that having that plan allows us to apply to different parks programs through OPRHP.

Ms. Woodburn explained there are three programs under Parks and Historic Preservation. If we don't have a Heritage Area Management Plan we don't have access to funding for historic preservation projects; our projects are referenced in this plan.

- 2. 239 Reviews (4)
 - a. 2024-012: Town of Nichols, Local Law to Reduce Members of Zoning Board of Appeals; recommended approval TCPB voted to recommend approval.

- b. 2024-013: Town of Owego, Site Plan Review, Little Creek Farm; recommended approval TCPB voted to recommend approval.
- c. County Case 2024-014NA: Town of Owego, Special Use Permit, Cortright applicant proposes to locate two campers on a property on Carmichael Road,
- contingent upon sale. Tioga County Planning Board waived their right to make a recommendation on this case due to lack of countywide or intermunicipal impacts, resulting in a non-action.
- d. County Case 2024-015: Village of Owego, Flood Damage Prevention Law Variance, Village of Owego Board of Trustees; recommended approval with the condition that the Village also obtains a required building code variance from the State Review Board – TCPB voted to recommend approval.
- G. Sustainability Management
 - 1. NYSDEC & PaintCare program Dr. Pratt sent an email informing the Legislators of this program and flyers regarding program were distributed at this meeting.
 - 2. Clean Energy Program-Fleet Inventory- Dr. Pratt and our intern, Mr. Umiker, met with Mike Brown with the Clean Energy Program to look for opportunities for the County. The County could get up to \$10,000.00 if we complete a fleet inventory. Those funds would be used to purchase electric landscaping equipment, LED bulbs and lights.
 - 3. Tioga County Debris Management Plan update- Dr. Pratt met with Mr. Hammond and Ms. Cornelius regarding updating this plan in 2025 and they were in support of doing this. FEMA would also have to approve. This would allow the county to obtain debris management contracts in the event there was a major flood event.

Trailblazing parking signs are ready for installation pending Village of Owego. Pedestrian plan and content are being updated and finalized. Fabrication and installation timeline will be updated pending village and steering committee review.

Online Services Grant

Four businesses are currently engaged in this course. An additional three applications have been received and will be reviewed pending consultant availability.

Tioga Antique Trail Campaign

TCT worked with Mediabrush marketing to create a comprehensive campaign to promote the Tioga Antiques Trail. This campaign began in mid-December and will run through the first quarter of 2024. It includes digital advertising, streaming commercials, videos and a new landing page at https://experiencetioga.com/antiques-trail/. The Tioga Antiques Trail Campaign reached over 50,000 people in Norther NY and Central PA. Deluge Media created a video to extend the campaign. Phase II of this project is being implemented.

Southern Tier Craft Beverage Trail

TCT, Visit Binghamton, and local craft beverage producers are reviving this trail that was created in conjunction with CCE pre-covid. It includes a passport system with branded prizes for consumers, a website and a robust social media campaign. Tioga has three locations on the trail. The Spring Scavenger Hunt was successful with over 50 participants. Pint glasses have been ordered as a prize for completing the passport.

Content Project

TCT is working with Team Tioga on coordinating a project with Deluge Media to gather and create a photo library and videos for multiple projects, including outdoor spaces throughout the county, events, lodging and other tourism niches.

Travel Guide

TCT has received approval to use Matching Funds for a new travel guide design, printing and distribution. Proposals are being reviewed and content gathered. We hope to begin design work in the first week of June.

Organizational Updates:

The following positions are currently open (closing 7/8/2024): Administrative Assistant (30hr/wk)

Introducing New CCE Tioga Staff:

Kelly Jackson, MS joined CCE Tioga Feb. 29th this year as the new *Agriculture Development Specialist*. Kelly earned her Masters in Entomology, focusing on lady beetle and aphid predator/prey interactions. Prior to joining CCE Tioga, she worked in the BTI greenhouses where she was the IPM Specialist and for CCE Suffolk as an Entomology Educator. Since joining CCE Tioga, she has joined a number of CCE Program Work Teams (PWTs) to broaden her knowledge-base to become a better resource for Tioga County, became a Regional Navigator for the *American Farmland Trust (AFT) Farmland for a New Generation (FNG)* program, and expanded the Spotted Wing Drosophila (SWD) monitoring program in the county (in collaboration with the NYSIPM program). Outside of work, Kelly and her husband have 14 acres in Danby where they're working on building a home and creating a permaculture garden filled with diverse plants to attract the best insects for her personal bug collection.

Local Public Outreach -

Attending Local Ag Meetings: Tioga County Farm Bureau, Agricultural Resource Group **Strawberry Fest:** CCE Tioga Staff and Board members tabled at Strawberry Festival providing Public outreach and information on the breadth of our programs, including a dedicated 4-H table with 4-H Educator Ben. *Master Gardener* Coordinator Jean created beautiful bouquets for the table to promote volunteer recruitment; Ag Specialist Kelly *WIOA* Youth Navigator Erin offered program Q&A; *FRC* Staff Joan & Donna gave out farm animal hand stamps and promoted Summer Programming; *SEC* staff Eileen & Bob provided energy advising to 44 residents, of which 8 residents, across three counties, requested home energy assessments. Exec. Director Kristi and Ag Specialist Kelly shared our Agriculture Support and Incubator programs. It was a beautiful day and a great way to connect with the community!

Campus Connection:

Kelly Jackson participated in the *Cornell Livestock PWT retreat* to learn about veterinary diagnostic capabilities available to all livestock farmers and updates on avian influenza. CCE Tioga Ag Team continues collaboration with Cornell University Dr. Kao-Kniffin's lab, currently growing four varieties of Rice in Seed Trials (~¼ acre) for the *Sustainable Crop Rice Project*.

- AFT FNG participation Regional Navigator networking calls to discuss strategies for providing technical assistance to farmers
- Participation in Tiger Planting Fest (Tioga Central school) demo with insects/spiders and clay art
- Berry Office Hours calls weekly Wednesday morning calls to interact with small fruit farmers and answer questions/address concerns they might have
- **Research Program:** SWD (spotted wing drosophila) trapping and monitoring at berry farms (weekly through July)
- Berry Call weekly meeting northeast extension educators discuss berry phylogeny/current development stages, pest occurrences, farmer concerns needing workshopping

Master Gardeners

Master Gardener Annual Plant Sale was very successful, connecting people with plants and fundraising over \$4,000! Weekly maintenance work on the various Demonstration Gardens and planning of more self-sustainable gardens at 56 Main.

Incubator Beginner Farmer Program at Hilltop Community Farm:

Currently we have two military veterans in our program. Over an acre of vegetables/flowers/ herbs in the ground. The first year of seedling production in our 30'x96' Greenhouse was a huge success as the incubator farmer's extra fee for greenhouse use paid for all of the propane usage. This allowed several farmers to sell seedlings at market and reduced their production costs, as they were able to grow nearly all of their seedlings instead of buying. Weed Management grant with the Toward Sustainability foundation growing a wide variety of winter squashes and trialing different weed management strategies.

CCE Tioga Hilltop Community Farm 2024 Incubator Farmer Cohort

Mike and Emily Quinlan, Ironwood Grazing Company, Sheep: Up to 65 sheep including lambs. They have moved offsite to another lease for the summer and will return to HCF in the winter. Selling ram lambs at auction in the winter and freezer lamb to select customers. Has tripled the number of lambs since joining our program.

Craig and Debbie Livermore, Loving Farms, Vegetables: Selling veggie boxes and participating in Ithaca's East Hill Market. They have tripled their production in the last two years with the help of CCE Tioga's Incubator program.

Stephanie Slate, Blue Hill Flowers, Cut Flowers: Growing cut flowers. Already has one wedding booked and the possibility of supplying the Statler Hotel at Cornell depending on yields. Vending at Ithaca's East Hill Market.

Joe Newlon, Joemato's Tomatoes, Vegetables: Growing vegetables, specializing in a wide variety of tomatoes, selling at Freeville Farmer's Market.

Theresa Alexander, Art Garden, Flowers, Herbs, Vegetables: growing vegetables, flowers, and herbs. Selling at Candor Farmer's Market.

Alicia Sanguliano, Alicia's Garden, Vegetables, Herbs, Flowers: Growing vegetables, flowers, herbs even some small grains and beans for seed saving. Possibly selling at Candor's Market. Increasing experience for her existing natural landscaping business.

4-H Youth Development

- CCE Tioga 4-H staff continue collaborative preparations for the Tioga County Fair (Aug 6-10) Youth/Ag/CCE Tioga events in collaboration with FFA and Fair Board members.
 - August 6-10, 2024 with Free Admission on Agriculture Day Aug. 6th

WIOA/Workforce:

- WIOA Youth Employment program PY-23 program year ends June 30, far exceeding enrollment goals for program year PY23 enrolling 46 youth. PY-24 begins July 1, we will hit the ground running with 4 youth ready to enroll on July 1.
- The WIB Board approved the CCE Tioga contract for continued services through June 30, 2025.
- We have 2 youth in Work Experiences: 1 at the Tioga Couty Career Center and 1 at the Open Door Mission. Both youth are doing very well and are improving their skills daily.

Success Stories: Working with one youth to enlist in the Marines and 1 youth began training at Oneonta Job Corp enrolling in the Automotive Body and Tech program. Three (3) youth gained employment in May/June (2 at local farms and 1 at Wegmans in Ithaca).

SWCD REPORT July 2024

AGRICULTURE PROGRAM:

- The District has several Ag Nonpoint Source Pollution Control grant contracts that are active and we are finishing this construction season. We have 5 farms completing riparian area plantings to complete their stream corridor projects, 2 farms involved in a cover cropping grant that will close out after fall implementation. We also secured Climate Resilient Farming grants and currently have two contracts on 2 separate farms that are also underway.
- A new round of funding applications is out for Climate Resilient Farming grant, we submitted a grant application for 1 farm to expand use of cover crops on 6/24.
- We are currently planning several farms to have them ready for future rounds of competitive grant funding that will be released this fall.
- We secured funding and are working with Tioga CCE, Cass Hill Road property, where we will construct two stormwater ponds at their facility this summer that will hold back a 100 year storm event providing flood mitigation to the downstream watershed, in addition we will be creating a wetland complex and planting 12 acres of riparian forest buffer.
- We are currently working on our Agricultural Environmental Management Program, this program provides funding to provide technical assistance to farms for planning and design conservation practices. We also secured \$200,000 in implementation funding with this program that we plan to work on 4 Best Management implementation projects and support 7 farms with buffer establishment over the next 2 years.
- Our no-till drills and post pounder have been out and are being moved around to interested farms.
 These are available to rent thru the District by contacting Alex Marks.
- We had 6 volunteer plantings this spring to plant buffers on participating farms and landowners property and are working on planning projects for the fall.

HAZARD MITIGATION:

We assisted the county and municipalities with the update to their Hazard Mitigation Plan, this plan once approved by all municipalities will be in place for 5 years (2024-2029). To date 13 municipalities and the county have adopted resolutions to accept the plan, we need 2 additional resolutions at this point and anticipate all municipalities adopting the plan.

STORMWATER:

We continue to review Stormwater Pollution Prevention Plans for the Town of Owego, many of these are for solar projects but also commercial development in the town. We also have an active contract to review solar plans with the Town of Nichols, but none requested this year.

STREAM PROGRAM:

- We continue to provide permit and design assistance to Landowner's and municipalities when it comes to stream work. We currently have 1 active stream project that we are doing construction oversight on in the Owego Creek Watershed.
- The County Water Quality Coordinated Committee coordinated our annual stream cleanup where groups can take advantage of cleaning up a stream and we take care of the garbage. Several cleanups happened including 1 community clean up on Owego Creek where we collected 1060 pounds of trash.
- We have an active grant with FEMA on Owego Creek where we are purchasing a home, plan to demolish and then stabilize a steep eroding bank. We also secured grant funding for the County IDA to complete a project on Owego Creek where streambank erosion is jeopardizing the railroad and utility line.

Education and Outreach:

- We held a pasture walk in mid-June and plan to conduct 2 more sessions this summer/fall. We are collaborating with the USC, SCDFC and CCE.
- Planning for Sundaes at the Farm is well underway; the event will be held on 7/21 at Frisbie Bros.
 Farm in Halsey Valley from 12-3.
- We are also preparing for the Tioga County Fair in August.

AUTHORIZE COMMITMENT OF CASH MATCH FOR BROOME-TIOGA SUSQUEHANNA HERITAGE AREA MANAGEMENT PLAN AMENDMENT ECONOMIC DEVELOPMENT & PLANNING

WHEREAS: Tioga County has been part of the Susquehanna Heritage Area along with Broome County since the Susquehanna Heritage Area Management Plan Amendment of 2009 expanded the area to the two designated counties; and

WHEREAS: The 2009 Susquehanna Heritage Area Management Plan is out of date and in need of modernizing to current day circumstances; and

WHEREAS: Broome County Department of Planning and Economic Development is writing and submitting a grant application to NYS Empire State Development's (ESD) Strategic Planning and Feasibility Studies program to update the 2009 Plan to an Arts and Cultural Master Plan for Broome and Tioga Counties; and

WHEREAS: The Arts and Cultural Master Plan will provide Broome and Tioga counties with an understanding of how they can improve and promote historic, cultural, and creative assets and identify opportunities to further increase tourism and economic activity; and

WHEREAS: There is a 50% cash match requirement for this ESD grant program and Broome County has requested that Tioga County partner to provide the cash match; and
