 - o Three clinicians have been hired
 - One of the three decided not to take the position
 - Currently have four openings in clinic & school based
- Governor has earmarked \$1 billion for Mental Health and continued care
 - No update on Tioga County's portion
- Brief overview of OASAS Grant & Opiate Abatement Money
- Open Access clinician completing evaluations quickly
- Remote Work policy passed
 - o Pilot program
 - Security policy updated
 - Remote work from county issued equipment only

 - Can be used to test the drug before use or after use via urine sample
 - New guidance from OASAS
 - Getting information & product out to the public
- Change in OASAS regulations
 - o Treatment goals have changed
 - Individual no longer needs to maintain abstinence; up to client's discretion
 - Meeting people where they are

Public Health - Heather Vroman

- Staffing still an issue
 - Looking for a Nurse and Part-time Dentist
 - Current Dentist works one day per week and is booked through July 2023

Rehabilitation Support Services – Larissa Brower

- Care Management
 - Department of Health Proposal
 - Would require clients to be discharged after 9 months of service
 - High risk/high need individuals could become community health workers for 3 months
 - Health Home Plus will be the ICMs

- Individuals would need to meet certain eligibility criteria for Health Home Plus
- A lot of advocacy trying to keep this from going through
- Slated to start in April 2023
- No idea the timeframe on readmittance to Care Management after discharge
- Process would start from ground zero

- Very Busy
- Trying to use Art Funds to expand shelter services (add staff)

- Donna asked Sarah about any clinicians using play therapy with kids
 - o Sarah will look into
- ADS involved in past community events

- o Held a Tie-Dye event over the past summer
- Wendy Arnold is doing suicide awareness events
 - o In Spencer on 3/2/23
- Tina Lounsbury reported there was an overdose in the Waverly High School yesterday (3/2/23). Outcome unknown
- Dr. Bezirganian gave a brief overview of the 2022 suicide attempt rates
 - o A lot of new staff in the clinic
 - Some incidents were found to be not actual attempts
 - o Some incidents had questionable events
 - Need to come up with another category to call these types of events
