MENTAL HYGIENE

- 1. Financial
 - Mr. Chris Korba noted that the 2022 budget is tracking well. He is expecting to have a return at the end of year. Fee-For-Service Revenue is for seven months, and Expense tracking is for eight months. Only 12.3% of the budget has been used, however there are some expenses that have not posted yet. There are no new reports of any criminal psych placement court orders.
- 2. Old Business
 - Criminal Psych No new orders to report.
- 3. New Business
 - Spencer and Tioga Central School Districts Ms. Morgan shared that these two school districts have received a grant for Mental Health therapists. The position at Tioga Central will be part-time and the position at Spencer will be full-time telehealth.
 - MAT (Medication Assisted Treatment) Jail Plan. Any methadone cases will be transported to UHS.
- 4. Personnel
 - Erica Kylor Sr. Clinical Social Worker starts 9/26/22.
- 5. Resolutions Resolutions were approved to continue.
 - Appropriation of Funds and Budget Modification (contracts pass through state aid funding).
 - Amend Budget and Appropriate Funds (joint with TCPH) Health Care Worker Bonus Program.

PUBLIC HEALTH

- 1. Financial
 - Mr. Denis McCann shared that the 2022 budget is "tracking well." Under 60% of expenses have been used. He expects to have a return in local share at the end of the year.

 - Agency Report for August 2022 forwarded to committee. Highlights were working with the food vendors at the Tioga County Fair. Environmental Health is working with potable water supplies.
- 4. Personnel
 - Tamie Jacobs, Accounting Associate III, hired effective August 1, 2022.

SOCIAL SERVICES

- 1. Financial
 - Mr. Gary Grant shared that there was a rate increase in the Foster Care lines but the JD line, OCFS, and payroll are under budget. A letter was received informing DSS the MA weekly shares will be reduced for the next 30 weeks which also results in savings. With some shifting around of revenue to cover the Foster Care lines, Mr. Grant expects to be under budget at the end of the year.
- 2. Old Business
 - None.
- 3. New Business
 - Caseloads

During August, Cash Assistance increased 3 cases, with Family Assistance increasing 1 case and Safety Net increasing 2 cases. Safety Net is down 15% for the year.

MA-Only increased 1 case. MA-SSI decreased 9 cases. Total Individuals on Medicaid increased 21 cases to 3,805. SNAP cases increased 16 cases. Day Care increased 18 cases. Day Care has gone up 38% for the year. There is a push on advertising as eligibility has expanded.

• Services cases increased 14 cases. See Caseload Summary and Charts.

Legislator Mullen expressed concern regarding kids leaving the Sayre School District and going to Waverly. They may be considering combining the 2 districts. He suggested Commissioner Yetter may want to discuss with the schools.

- Tioga Career Center report is attached. The unemployment rate in Tioga County went up slightly but remains below the State & Federal rates. There were 36 new UI claims filed in August.
- 4. Personnel Changes
 - Ashley Wright, OS1, hired effective 8/15/22.
 - Christopher Titus, Case Supervisor Grade B Services, last day effective 8/18/22.
- 5. Resolutions Resolutions were approved to continue.
