FINANCE, LEGAL & SAFETY COMMITTEE MEETING MINUTES - FINANCE June 13th, 2023 AT 10:30AM

ATTENDANCE:

APPROVAL OF MINUTES: Minutes of the May 9th, 2023 Finance Committee were read and a motion to approve by Legislator Mullen, seconded by Legislator Flesher and unanimously carried.

FINANCIAL: Treasurer McFadden reviewed the TYD Office budget report for fiscal year 2023, highlighting the \$40,000 payment from the Tobacco settlement which is expected to be received next week and the continued increase in Interest income from invested funds.

OLD BUSINESS: The tentative list of 2021 tax foreclosure properties was presented and the current status was discussed. 26 properties are on the tentative list, of which 6 are in discussions for purchase by the Land Bank and 2 are scheduled to close this week, requiring the payment of taxes at that time. Brittany Woodburn discussed the Land Bank's intentions with a few of the properties they are proposing to purchase.

NEW BUSINESS: The impact of the Tyler v. Hennepin County decision was discussed with updates provided by County Attorney DeWind. A 1 year foreclosure moratorium is expected to be passed by NYS effective July 1st. For this year's auction to proceed on August 10th, 2023, the County will be foreclosing and taking title before July 1st and proceeds will be kept in a separate trust account awaiting further guidance from NYS. The Annual meeting of the Tobacco Asset Securitization Corporation will be held on June 14th, 2023. Moody's Investors Service credit rating statement was presented, reflecting another year with an A1 rating. The results of the 2022 Indirect Cost Recover Project were reviewed, highlighting the \$1,256,308 additional Federal Aid claimed based on the calculations provided by the Venesky Group at a cost of \$14,000. An annual Fiscal Advisor's report was distributed to the Legislators for review. This report is registered with the Security and Exchange Commission on Wall Street.
