APPROVAL OF MINUTES

FINANCIAL

The monthly financial reports were accepted as presented. The Clerk reported that the revenue from criminal background search requests brought in \$21,240.00 for the month of October. The criminal records search requests have resulted in a considerable increase in revenue in 2024 when compared to the same timeframe in 2023.

The Clerk then reported that the Clerk's Office staff have an efficient procedure for handling criminal background check requests. The Clerk's Office and the Office of the Court Clerk have worked out a process to handle requests for searches and certificates of disposition that has cleared up the backlog and gets results back to the search companies in a timely manner.
