Staff: Legislative Clerk Haskell, County Attorney DeWind, Treasurer McFadden, Deputy Treasurer Chandler, Safety Officer Holbrook, Personnel Officer Parke, Public Defender Awad, Accountant Schurter

- APPROVAL OF MINUTES:
 - Legislator Ciotoli asked for a motion to approve the November 14, 2023, minutes. Legislator Brown made the motion seconded by Legislator Monell and was unanimously carried.
- FINANCIAL:
 - Legal and Safety's budgets are tracking well with funds being used before the end of the year. Legal is expecting some invoices for professional services but there is still available funds in Legal's budget to cover these fees.
- OLD BUSINESS:
 - Litigation: No new claims have been filed against the County. Mr. DeWind is still addressing claims from previous In Rem foreclosures. The claims against the Sheriff's Office are still on track with trials expected in 2024.
- NEW BUSINESS:
 - Resolutions: The resolutions were discussed with no questions from the Legislators.
 - New Visions/Law & Government Academy runs an internship program for local high school students. Mr. DeWind has been contracted and asked to host a student from the Newark Valley High School. The program would run January 30 to Feb 21, 2024, every Tuesday and Wednesday from 8:00 AM till 12:00 PM. The Public Defender and District Attorney's Office have both offered to host the student for a week. Mr.

DeWind asked the Legislators for Legislative approval as required by County Policy which was granted.

- Mr. DeWind submitted Ms. Holbrook's Safety Officer's Report for 2023 for duties completed during this year. Legislator Standinger asked Ms. Holbrook's opinion on Emergency Services purposed fly car program. Ms. Holbrook stated the program had merit.
- Mr. DeWind met with Indigent Legal Services (ILS) to put a budget in place for a project that covers years six (6) to eight (8). Broome's ILS project is in flux and at this point has no plans to partner with ILS for a joint meeting space. ILS has looked at space in the Court Annex basement and the basement at 56 Main Street as a possible space if ILS is unable to secure an offsite location.
- Mr. DeWind attended the CAASNY Winter meeting where In Rem updates for the coming year were discussed. Counties are still going to lose the overage which will now go into a separate account and landbank properties will no longer be able to purchase properties for one dollar (\$1 USD) from the County. Price evaluations will need to be conducted and there are three (3) separate pieces of legislation that should provide more detail on what this process will look like.
- PERSONNEL:
 - A candidate has been interviewed and has accepted the position of Secretary to the 1st Assistant County Attorney. They will start December 18, 2023.
- RESOLUTIONS:

WHEREAS: By Resolution No. 432-23 adopted on November 14, 2023, Tioga County entered into a three-year agreement with the New York State Office of Indigent Legal Services for distribution of funds to provide representation to persons legally entitled to counsel but unable to hire an attorney; and

WHEREAS: The allocated amount to Tioga County from NYS Office of Indigent Legal Services for the fiscal year April 2023 – March 2024 is \$761,014.42; and

WHEREAS: It is necessary for Tioga County to adopt the sixth-year funding budget for said distribution in said amount of \$761,014.42; and

WHEREAS: Said funding in the amount of \$761,014.42 needs to be appropriated and the 2024 budget be amended; therefore be it

RESOLVED: That the Tioga County Legislature hereby approves the six-year budget of said distribution in the amount of \$761,014.42; and be it further

WHEREAS: Legislative approval is required for any appointments made to a Management/Confidential position; and

WHEREAS: As of January 1, 2024, the position of Assistant Public Defender has been vacant due to promotion; and

WHEREAS: The Public Defender has recruited for a replacement and after interviewing, a satisfactory candidate has been identified; and

WHEREAS: Mr. James Davis has over 14 years of relevant legal experience including extensive experience in upstate New York Courts with every stage of representation of indigent defendants and including felony trial experience, and further comes with excellent references from his current employer; therefore be it

RESOLVED: That the Public Defender is hereby authorized to appoint James Davis to the title of Assistant Public Defender, with a start date of January 29, 2024, at an annual Management/Confidential salary of \$86,644; and be it further

RESOLVED: That in accordance with Tioga County's Civil Service Rules, Mr. Davis shall serve a probationary period of eight to fifty-two weeks; and be it further
