- (6) You have a right to a replacement ballot. If you make a mistake or want to change your vote, call the Board of Elections at 607-687-8261 for instructions on how to obtain a new ballot.
- (7) After completing your ballot, insert it into the OFFICIAL BALLOT ENVELOPE provided, seal and sign.
- (8) Return your ballot to the Tioga County Board of Elections by following the instructions printed on the OFFICIAL BALLOT ENVELOPE.
