The Clerk updated the Committee on the status of the Clerk's Office and the DMV. The Clerk reported that she has received two emails from the Tyler Project Manager that contained several questionnaires to be completed to form a basis for the conversion of the records management system from COTT to Tyler. The Clerk let the committee know that she will share any or all such communications with the Legislature if needed. The Chair stated that the Clerk may share these emails at her discretion. The Clerk then updated the Committee on the transition of notary renewals from the local County Clerks across the state to the NYS Department of State and the frustrations of the NYS Association of County Clerks. The Clerk pointed out that the state's notary portal sometimes has outdated or incorrect information about individual notaries. These discrepancies are reported to the

This will make it impossible for a Clerk to verify the signature of a notary when asked to produce a certificate of official character for said notary. The NYSACC notary committee is also aware of this issue.

The Clerk stated that the DMV is a little slow right now but that is typical for this time of year. The new cashier is doing a great job so far and is very good with the customers. der.
