I submitted a certified FOIL request for Register of Poll Watchers/Inspectors/Clerks from the TiogaCounty Board of Elections by written statement made on July 14, 2022. The following information is stated in the original certified FOIL request below.

In accordance with the New York Freedom of Information Law ("FOIL"), Public Officers Law § 87 *et seq.*, I hereby request the following *records* produced, in the original, copied image or common electronic format within five (5) business days as stated in POL § 89 3 (a) you must grant the request, deny the request in writing, as well as provide a certified response for the reason of any denial in whole or part, or provide a date certain when such a response will be provided.

Select the choices for:

- ALL records
- SEPARATE file per batch
- JSON format

Then, after that CVR report is generated, run the action again with the choices for:

- ALL records
- EXCEL format (xlsx)

I request a text, comma or tab delimited file, or a text-based report, listing, in the sequence processed by the county, every ballot, it's sequential ID, its timestamp, its method of voting (early inperson, absentee,

mail-in, in person – whichever apply to the county), the specific votes contained for all races, and the batch id and tabulator id. Should any fields not be available, please include the fields which are. To be clear, I am not requesting a summary report of votes, I am requesting a per-ballot report. This set of information is sometimes known as a "cast vote record", "ballot log", or a "summary of ballots". If the data exists as multiple files or reports, for instance by batch or byprecinct, you do not need to aggregate them, please send the individual files. I specifically do not want included any information which identifies a specific voter, and I guarantee and stipulate that this information will not be used for that purpose.

*"Records"* means any information kept, held, filed, produced or reproduced by, with, or for this agency, in any physical form whatsoever including, but not limited to, reports, statements, examinations, memoranda, opinions, folders, files, books, manuals, pamphlets, forms, papers, designs, drawings, maps, photos, letters, microfilms, computer tapes or disks, rules, regulations or codes as stated in Article 6 of The Freedom of Information Law.
